According to article 50 of the By-laws of the BFPT, the applicants whose membership has been approved should pay a one-time affiliation fee of 295 (two hundred and ninety five) BGN. The annual membership fee is 80 (eighty) BGN. Also, 20 (twenty) BGN should be paid per vehicle for those vehicles by which the activities of a carrier are performed. •
